Dear Mr. Cude:

The City Staff Development Review Committee has reviewed Great Northwest Subdivision Master Development Plan M.D.P. # 755. Please find enclosed a signed copy for your files. Your plan was accepted, however please note the following:

- In consideration of public safety and convenience, excessive grades by reason of topography should be avoided in street layouts and arrangements.
- Any access and R.O.W. issues along state facilities will need to be resolved with the Texas Department of Transportation (TXDOT). For information about these requirements you can contact TXDOT at 615-5814.
- This development will need to comply with tree preservation ordinance #85262. For information about these requirements you can contact Building Inspections at 207-7102.
- It will be expected that you will plat all of the property depicted in your Master Development Plan (M.D.P.) to include floodplains, drainage areas and open space.
- Development Services, Engineering Section has indicated as part of their conditional approval, the following conditions shall be met by the developer at the time of final plat submittal:
 1. Any none compliance to street dedication and minimum street right of way width requirements will have to comply with Section 35-435 Subdivision Plat Variances and Section 35-483 Subdivision Variances as per the Unified Development Code (UDC) of the City of San Antonio Planning.


- The Parks and Recreation Department as part of their conditional approval impose the following:
 1. The applicant has selected to meet the park dedication requirement through the payment of a fee in-lieu of dedication. Based on documentation submitted by the applicant, the fee for this project is \$12,070.24. Prior to the recordation of the first plat filed under this Plan, the amount of \$12,070.24 is to be paid to the City of San Antonio Parks and Recreation Department.
- I would encourage you to work closely with the school district, so that they can plan accordingly.

Please note that this action by the committee does not establish any commitment for the provision of utilities, services or zoning of any type now or in the future by the City of San Antonio. If the proposed development is not platted in phases this Master Development Plan M.D.P. will be invalid.

ALL Platting shall comply with the Unified Development Code, Master Plan and Major Thoroughfare Plan for the city of San Antonio.
