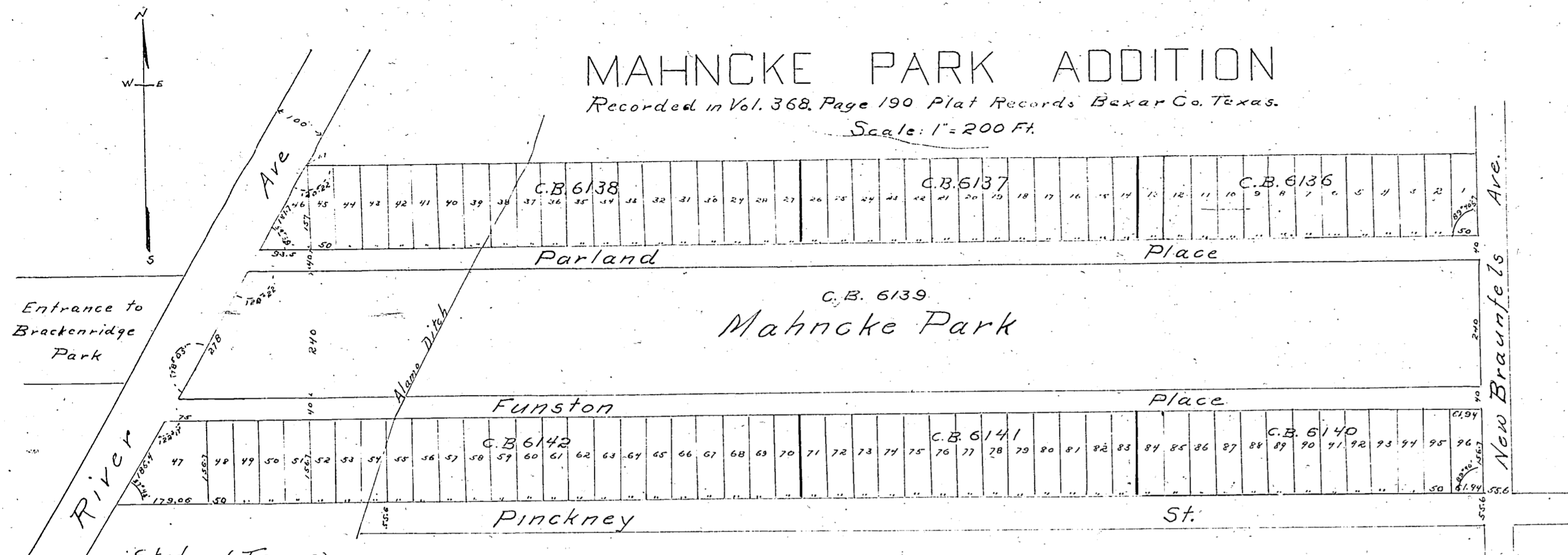

Know all men by these presents: We Walton & Arneson, Surveyors, and Mrs. Kate Jones and Henry C. King, Jr. owners, do hereby certify that the plat shown hereon, is a true and correct plat of "Mahncke Park Addition," to the City of San Antonio, taking the place of all previous plats of said property. The particular property covered by said plat being a subdivision of the following described real estate, to-wit:

1st: Being that part of those certain tracts or parcels of land, designated and described as "first tract" in deed from Travis F. Jones and W.C. Lott to James A. Logwood, dated June 21, 1910 recorded in Vol. 339 page 268 deed records of Bexar County, lying south of and adjoining a strip of land, on the south side of Mahncke Park, deeded to the City of San Antonio, by Mrs. Kate Jones, Travis Jones and Henry C. King, Jr. by deed dated December 18, 1915, recorded in Vol. 472 Page 593, deed records of Bexar County.

2nd: Being that part of those certain tracts or parcels of land, designated and described as second tract in deed from Travis Jones and W.C. Lott to James A. Logwood, dated June 21, 1910 recorded in Vol. 339, page 368, lying north of and adjoining a strip of land on the north side of Mahncke Park conveyed to the City of San Antonio, by Kate Jones, Travis Jones and Henry C. King, Jr. by deed dated December 10, 1915, recorded in Vol. 472, page 593, excepting therefrom, however, that part of said second tract situated between Alamo Ditch and River Avenue lying north of a westerly extension of the north line of lot 18, R. 1, D. 2, from where it intersects Alamo Ditch.
