# WHAT DO CODE OFFICERS DO?

Code Enforcement Officers work to keep San Antonio a safe, and healthy place to live. They make sure residents follow the rules or "codes" on how homes, yards, and buildings should be built and maintained.



WHY IT MATTERS

Following our Codes helps prevent things like:

- Dangerous buildings
- Trash piles that attract bugs or animals
- · Fires caused by tall grass or junk
- Neighborhoods looking rundown

# WHAT PROBLEMS DO THEY LOOK FOR?

Here are some common issues Code Officers check for:

Common Violations	Why it's a Violation
Tall grass and weeds (over 12 inches)	Can attract pests like rats or mosquitoes.
Inoperable vehicles	Can leak harmful fluids and lead to graffiti.
Trash in yards and storage buildup	Can attract animals and cause smells.
Broken windows or falling fences	Can be unsafe for people and pets.
Illegal signs or garage sales	Must follow City Codes for safety and fairness.



# WHAT IF THERE'S A CODE VIOLATION?



- 1 Resident reports a concern by calling 311 or online.
- The officer checks the property and takes notes & photos.
- 3 A notice is given if a violation is seen.
- 4. Time is given (usually 7–30 days) to correct the problem.
- 5 A follow-up inspection happens to see if it's fixed.
- 6 If not fixed, a fine or repair may be issued by the City.

If the issue is fixed, no additional notices are sent to the owner.

### **HOW IT WORKS**

When a concern is reported through "311," here's how we handle it:

- Days 1-3: A Code Officer visits the property to check if there is a violation.
- If there's a violation: We start a case and give the notice, giving the owner 10 days to fix the problem.
- Days 10-20 (depending on the violation): The
  officer checks again. If the violation isn't fixed, they
  give a citation for a court visit. If the concern is
  fixed, the case is closed.
- 45 Days: Our goal is to have 90% of violations to be fixed in 45 days.
- Some cases: Certain issues, like zoning problems or dangerous buildings, may take up to 6 months or longer to address.
- Contesting: Residents can contest San Antonio Property Maintenance Code (SAPMC) violations through the Building Standards Board (BSB).

# ZONING & LICENSING ENFORCEMENT TEAM

The Zoning & Licensing Team is a group of highly trained Code Officers who make sure that City businesses and buildings follow the Code. They check things like property zoning and building permits. They also make sure certain places have the right licenses, like:

- Used Automotive Parts Recyclers
- Metal Recyclers
- Scrap Tire Facilities
- Donation Containers
- Mobile Living Parks
- Boarding Homes
- Short Term Rentals
- Refurbished Mattresses and Germicidal Permits



### NEIGHBORHOOD ENHANCEMENT TEAM (NET)



This special team goes into busy areas of the city that need extra help. The NET Team partners with the community to:

- · Clear properties with high grass and weeds
- · Educate in-need residents of our Tool Shed program
- · Conduct high-impact curb appeal inspections
- Teach neighbors how to report issues



### HOW WE ARE DOING

#### **Quick Response Times**

Code Officers are working fast! On average, inspectors arrive in **1.2 days** for serious code issues (like unsafe buildings or illegal dumping) and **1.4 days** for less urgent problems (like yard maintenance). Our goal is 2–3 days, and we are exceeding it!



#### **Fast Fixes on Violations**

If there's a problem, it gets fixed in **45 days or less**. Right now, **91%** of issues are taken care of in that time. That means safer, cleaner neighborhoods!

#### Residents Report

Many violations are reported by neighbors. Residents have made around **54,000** code complaints in the last 5 years. Our Inspectors are ready to help solve these problems! If you see something, say something. Call 3-1-1.



#### **Less Litter**

Great news for clean streets! The litter index score is down, showing a drop of about **9%** over the last 5 years. This means less trash in our City.



#### **Fewer Dangerous Properties**

The number of vacant, unsafe buildings is decreasing. This year, there are **95 fewer** dangerous buildings in the City, compared to last year.



### RESPONSIBILITIES FOR RESIDENTS

To stay in good standing, homeowners and renters should:

- Cut grass and weeds regularly
- Keep trash in bins with lids
- Don't store old furniture or junk outside
- Only put up signs if allowed
- · Keep fences and walls safe and stable

You might need a permit for things like:

- Home renovations and repairs
- Garage sales
- Running a boarding home
