All fees identified in RED in this schedule are considered development fees that are waivable under the City Fee Waiver Program.

## BUILDING DEVELOPMENT FEES

The Building Development fees are assessed for plan review, inspections, certificates of occupancy, and trade licenses, and renewals. Commercial and existing residential building plan review and permit fees are based upon valuation. New residential building plan review and permit fees (including trade permit fees) are based upon square footage. For new commercial construction, the building plan review fee includes the following reviews: Building, Fire, Electrical, Mechanical, Plumbing, Street, Traffic, Drainage, Aviation, and Historic Preservation. The department also has review fees for reviews involving only one trade. Commercial trade permit fees are based upon a flat rate plus additional charges for specific items inspected.

## BUILDING PLAN REVIEW AND PERMIT FEES

### Residential Construction - New, Remodels, and Additions

The plan review and permit fees for new residential construction is based upon the project's square footage. Under the new fee structure, customers will pay for their trade permit fees at the time the building permit is issued. These fees will be assessed to the building permit. Electrical, mechanical, and plumbing subcontractors will still need to obtain a separate permit but the permit fees will not be assessed if the fees are paid on the building permit. The subcontractor will need to link their permits to the parent permit using the parent-child relationship. Unfinished interior building permit fees are discounted 50%.

## Commercial Construction

Development Services establishes minimum values for the cost of commercial construction based upon the costs per square foot as published and updated by the International Code Council and used with the Army Corp of Engineers’ modifier for the City of San Antonio. This value is established at the time the building plans are submitted. Additional valuation checks may be performed by the plan examiners during their review of the plans.

## New Commercial Construction - Complex Plans

Beginning with the launch of BuildSA in the winter of 2020, a flat fee based on occupancy group and square feet for commercial trade permit fees will be assessed. Below are the fees for Occupancy Groups A (Assembly), B (Business), E (Educational), F (Factory and Industrial), H (High Hazard), I (Institutional), M (Mercantile), and U (Utility and Miscellaneous). Projects with an S (Storage) occupancy group will be calculated at 50% of fees noted below (with a minimum fee of \$100.00).

As noted in above table, there is an additional charge beyond the flat fee when the size of a project is greater than the base size. For example, an Occupancy B project size area equal to 1,901 square feet:

- 1,000 sq. ft. base fee = \$100.00
- Each additional 1,000 square feet or increment thereof over 1,000 square feet will assess an additional charge of \$5.00
- Total Fee= \$100 + [\$5.00 x (1,901-1,000)/1,000] = \$104.51

Rather than paying a fee of \$100.00, the final fee is \$104.51 for a project that is 1.901 square feet in size.

Beginning with the launch of BuildSA in the winter of 2020, a flat fee based on occupancy group and square feet for commercial trade permit fees will be assessed. Below are the fees for Occupancy Groups R1 (Residential – Hotels) and R2 (Residential - Apartments).

**For partial/phased commercial permits, the above fee structure for both sets of occupancy groups (listed above) will be applied, but the Mechanical, Electrical and Plumbing (MEP) fees will be charged in BuildSA, starting in winter of 2020, as follows:**

<b>Commercial Building – “Partial Permits” for Site Work, Foundation and Shells</b>	
Site Work	10% of Electrical & Plumbing fees only (with minimum fee of \$100.00)
Foundation	10% of Electrical & Plumbing fees only (with minimum fee of \$100.00)
Shell	80% of Electrical & Plumbing and 100% of Mechanical fees
Interior Finish Out	100% of MEP fees

When a partial/phased approach is taken, such as completing only the site work, a proportion of fees will be assessed. For example, a phased project for Occupancy B with Site work equal to 50,000 square feet with electrical work indicated by customer:

50,000 sq. ft. base fee = \$1,245.00  
 Electrical Fee: \$100 \* 10% (\$1,245.00) = \$124.50

## Plumbing, Gas, Sewer Permit Fees – Commercial and Existing Residential

Beginning with the launch of BuildSA in the winter of 2020, a flat fee based on occupancy group and square feet for commercial trade permit fees will be assessed.

School districts with school district projects valued at \$500,000 shall be entitled to a 25% waiver of plan review and permit fees, but in no case shall said school district pay less than a minimum fee of \$868.40 for plan review, \$1,410 for building permit, and \$136.70 for the related surcharges.

For electrical work associated with new residential construction, the electrical permit fees are based upon square footage and will be assessed on the parent building permit. These fees do not apply to electrical work associated with swimming pools and electrical work not associated with the initial residential building permit application. TML's, TOP's, and Gas permits are based upon a flat fee as indicated below. For new residential, your electrical permit must be linked to the parent permit:



