# BACKGROUND

---

- Original ordinance adopted in 2008
- Current ordinance adopted in 2012
  - Changed salvage yards and auto dismantlers to:
    - Used Automotive Parts Recyclers (UAPR)
    - Metal Recycling Entities (MRE)





# DEFINITIONS

## Metal Recycling Entities

MRE is defined in Ch. 16-203:

- Acquiring and purchasing scrap, used, or obsolete ferrous or nonferrous metal
- Performing the manufacturing process by which scrap, used, or obsolete ferrous or nonferrous metal is converted into raw material products



## Used Auto Parts Recyclers

UAPR defined in Ch.16-186

- Dismantling and reuse or resale of used automotive parts **and**
- Safe disposal of salvage motor vehicles or nonrepairable motor vehicles, including the resale of those vehicles

### Issue Proposed for Consideration

Requesting the creation of a stakeholder taskforce charged with evaluating and recommending amendments to the San Antonio Code of Ordinances, specifically Chapter 11 Fire Prevention and Chapter 16 Licenses and Business Regulations, that ensure adequate enforcement of city codes relating to used automotive parts recyclers (UAPR) and metal recycling entities (MRE).

### Background

Used Automotive Parts Recyclers (UAPR) and Metal Recycling Entities (MRE) are facilities key to our city's recycling ecosystem and circular economy – many of them have been part of our community for decades. While they are part of what is considered the sustainable economy, the process of recycling used automotive parts and metals often results in serious pollution for the surrounding area that can cause detrimental health issues in people.

Air emissions such as volatile organic compounds (VOCs), particulate matter and ozone, lead, mercury, and other hazardous air pollutants stem from much of the work UAPRs and MREs conduct during the breakdown process of onsite materials. These emissions, especially with long-term exposure, can lead to cancer, respiratory diseases, liver damage, neurological damage, and other dangerous health effects. While hazardous air emissions are most dangerous to people working and living near these facilities, they also threaten the health of all residents throughout the city of San Antonio as air pollutants can travel can travel hundreds of miles away from their original source.

# FOCUS AREAS

---

- Timeline and process for issuing and resolving citations
- Fines for recurring violations
- Identifying a threshold for triggering heavier enforcement mechanisms until violations and citations are resolved
  - Temporarily ceasing operations
  - Requirements of fence line air monitors for limited time
  - Removal of non-conforming uses
  - Fines to recoup city services used to address violations and emergencies

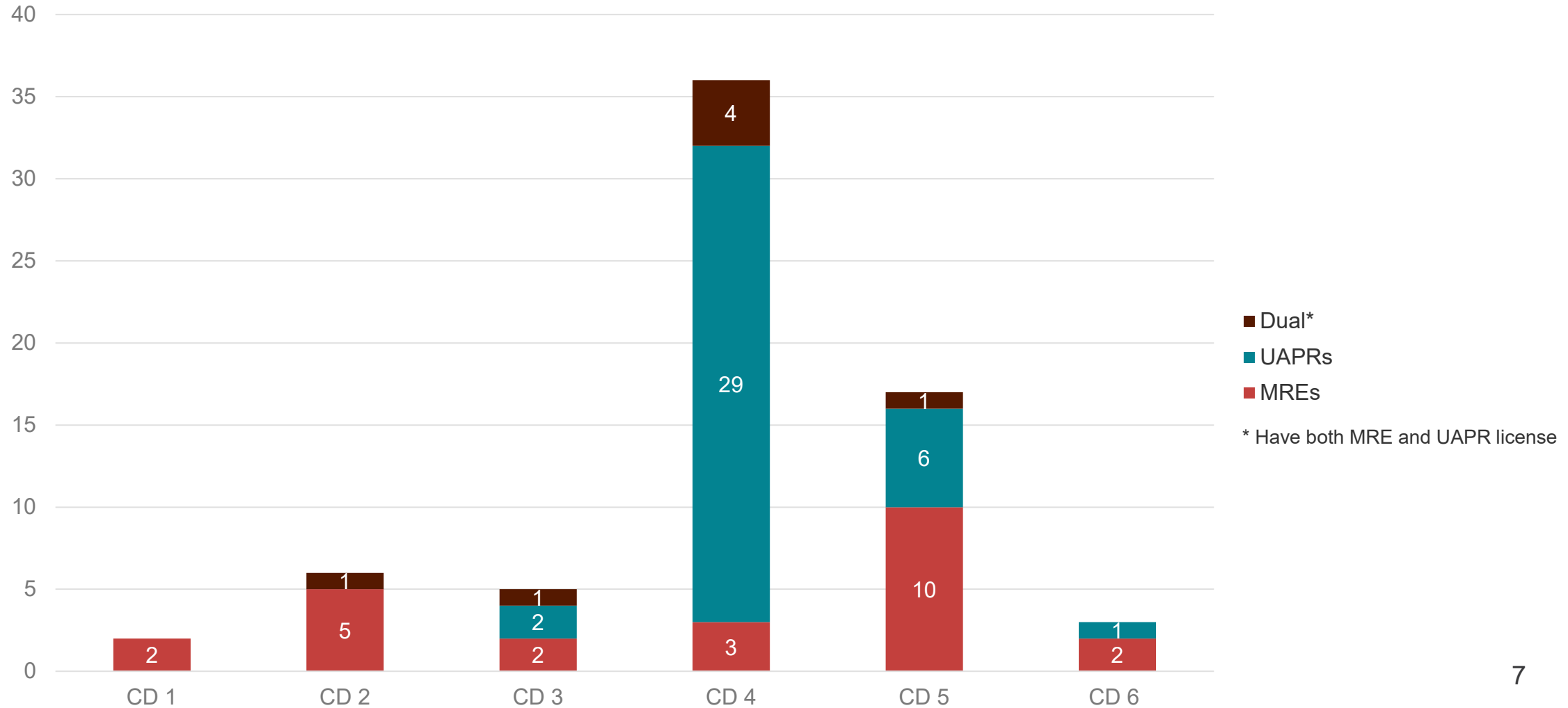

- No current citations



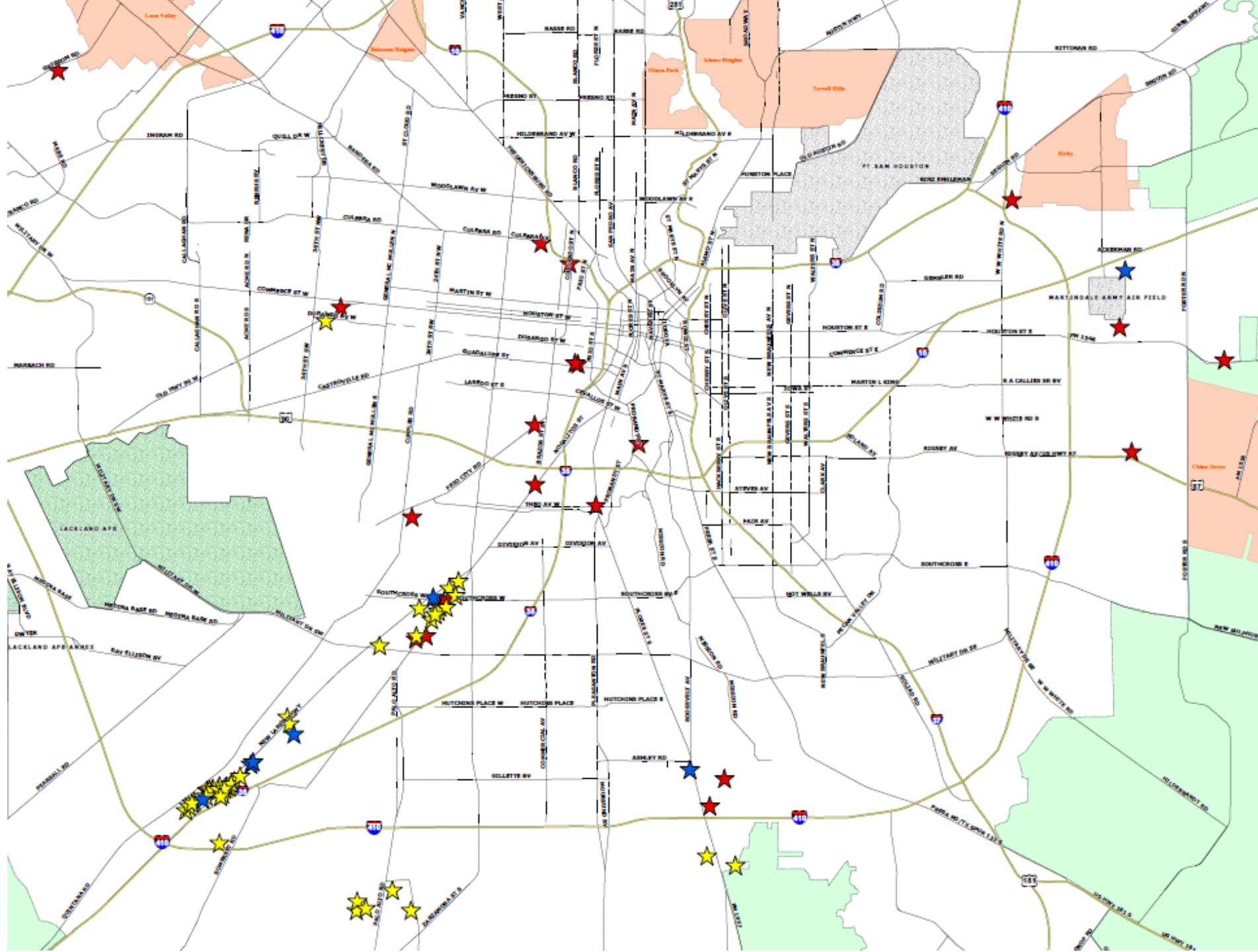
# METAL RECYCLING ENTITIES & USED AUTO PARTS RECYCLERS IN CITY

- ★ Dual



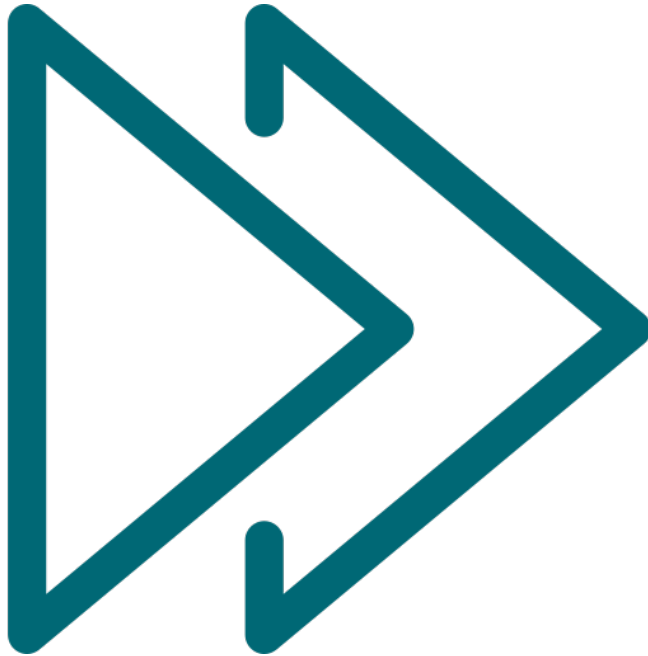

---



- Staff recommends creation of stakeholder group to review and propose amendments in Ch. 11 & Ch. 16
  - 10 members chosen by City Council
  - 10 industry representatives (5 MREs and 5 UAPRs)
  - City staff (CAO, DSD, SAPD, MH, SAFD, SWD)
  - Other agencies (TCEQ, SAWS)
- Hold Task Force meeting over 6-month timeframe
- Brief PCDC on task force recommendations Feb. 2025
