Residential and Commercial Foundation Repair Permits

Purpose:

As a customer service initiative, the Development Services Department (DSD) **revised** this Information Bulletin (IB) 172 to clarify the requirements for residential foundations repair and/or commercial foundations repair and/or replacement permits. This bulletin has been updated to include information concerning the on-line application, and on-line submittal of documents.

Scope:

The online application for a Foundation Repair Permit, and an electronic pdf version of the Assumption of Engineer of Record Letter, as well as any electronic construction documents, are submitted to the City through the [BuildSA ACA Customer Portal](#). A double fee will be assessed for failure to apply and obtain a permit before starting work. The specific requirements are as follows:

Application (Pre-Permit) Process

The application for a foundation repair must be obtained by either:

1. For Residential the property owner, or a City licensed and active Residential Building Contractor.
 2. For Commercial, the property owner or a general contractor. A licensed contractor with the City is not required for commercial.
- Apply online by logging into the [BuildSA ACA Customer Portal](#).
 - Under the Building Module from the main screen, click on “Create an Application”.
 - Click on the “Minor Building Repair Application” from the list of all permits available.
 - Start the application by entering the address of the foundation repair work.

- Choose the type of application by choosing “Foundation Repair Permit” from the drop-down menu. The Minor Building Repair Application includes several types of repair permits that may be obtained.
- Choose Residential or Commercial for the type of building foundation being repaired.
- For Commercial enter the valuation of the work (total of all material and labor).
- Enter the contact information. Typically, the applicant is the licensed/registered foundation repair contractor, and the system recognizes the license. Under “Applicant Also Known As”, never check “Company Name/Business Owner. Check “Escrow Owner” to pay later by the company escrow account. On the next screen use the “Look Up” button to add the Company associated with the license. If you are the property owner applying and taking responsibility for the work, check the box that you as the applicant are the property owner.
- Upload electronic pdf documents after filling out information about the repair.

City Completeness Process

After the application is submitted, the City will perform a review, and may ask more information, before a permit is issued. Submittal and obtaining an application record number is not a permit to start repairs. The application process creates a Building Repair Permit Application under its own record number. Once the application is approved, a separate permit record for a Foundation Repair is created for inspection purposes (with a separate record number).

Permit Electronic Document Required:

Residential and Commercial Foundation repairs shall be designed by or performed under the engineering guidance of a professional engineer licensed by the State of Texas (who shall also perform inspections). To complete a permit application, submit the following:

- Complete the on-line permit application by logging into the [BuildSA ACA Customer Portal](#).
- Upload the Assumption as Engineer of Record Letter signed and sealed by a professional engineer licensed by the State of Texas, submitted on-line during the application in PDF format. (example attached)
- (Optional) Submittal of electronic copy (PDF) stamped and sealed engineering construction documents.

Permit (Inspection) Process

SUBMISSION OF ENGINEER’S LETTER

Submission of an electronic copy of the Engineer’s Inspection Letter from the Engineer of Record – All foundation repair inspections are cleared by submission of an electronic pdf version of an Engineer’s Inspection Letter. This electronic letter in pdf format is uploaded to the permit record. The Letter must follow the attached template. Only letters from the Engineer of Record will be accepted.

Additional Project Requirements

Some foundation repairs may have additional requirements based on the specific foundation. These include skirting/ventilation/subfloor access and drainage away from foundations for both residential and for commercial.

Skirting Removal, Repair or Replacement, Drainage, Ventilation, and subfloor access: The International Residential Code requires that subfloor spaces be provided with adequate ventilation and subfloor access. As indicated above, submission of the Engineer Inspection Letter includes inspect results for all foundation repairs. As an option, any skirting removed, repaired, or replaced along with ventilation, sub-floor access and drainage may be optionally included within the list of items inspected by the engineer, as part of the engineer's inspection letter, however a City final building inspection is still required for these items.

Notification of change of Engineer of Record – In the case that an Engineer of Record changes after the submittal of the application, two items are required to be submitted to The City of San Antonio, Development Services:

1. A letter from the original Engineer of Record (EOR) stating that he/she is no longer involved with the project.
2. A new Assumption as Engineer of Record Letter submitted from the new professional engineer taking responsibility as the EOR.

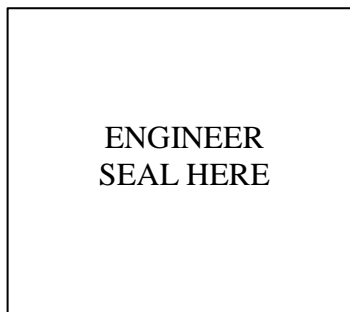
