Fast-Track Metal Stud Permits

Purpose:

As a customer service initiative, the Development Services Department (DSD) created this **revised** Information Bulletin 120a to inform our customers of how to obtain optional fast-track metal stud permits. This bulletin has been updated to incorporate the department's new format for Information Bulletins. The purpose of this information bulletin is to allow general contractors to legally start work without delay on interior finish out projects in existing buildings before the final building construction plans for the interior finish out have been reviewed and approved.

Scope:

To obtain this optional permit, after submission of the design package for the full interior finish out permit, the applicant completes a Fast-Track Metal Stud Permit Application (attached) and pays a nonrefundable building permit fee based on the estimated cost of construction and submits at the front counter at DSD. Since plans must be submitted for the interior finish out permit, design documents are not required to be submitted with a Fast-Track Metal Stud Permit Application. The fee for the Fast-Track Metal Stud Permit will not be credited toward the full permit fee. If separate permits are anticipated for various segments of the job, separate Fast-Track Metal Stud Permit applications will be required.

Issuance of a Fast-Track Metal Stud Permit requires the acknowledgment by the project owner and the general contractor that the issuance of a Fast-Track Metal Stud Permit is at his/her own risk and any work that is found not to comply with the construction plans for the interior finish out after approved by the City shall be corrected. The issuance of a Fast-Track Metal Stud Permit also provides no assurance that either the permit for the interior finish out will be issued or that a Certificate of Occupancy will be granted.

- No work other than the installation of interior, non-load bearing, metal stud framing will be allowed under this permit.
- No work will be inspected without the previously submitted full interior finish out permit being reviewed, issued and the city approved plans on the job site.
- No work may be concealed without inspection approval.
- No Certificate of Occupancy will be issued without inspection approval.

STATEMENT OF UNDERSTANDING

- No Certificate of Occupancy will be issued without inspection approval.

Furthermore, the applicant agrees to proceed with the development and obtain approval of the design documents as soon as possible. All review issues shall be resolved, and the full permit shall be obtained without delay.

Finally, I understand that the issuance of Fast-Track Permit at my own risk provides no assurance that either the permit for the interior finish out will be issued or that a Certificate of Occupancy will be granted.
