*** Insurance and Bond Information ***

(City Code of Ordinances section 10-117 details specifics for irrigation contractors including insurance and bond requirements.)

Applicant is required to obtain and maintain insurance meeting or exceeding specified amounts to include:

- Public liability – \$300,000 per occurrence
- Property liability – \$300,000 per occurrence

Applicant may provide bond coverage in the amount of \$10,000.00 from a bonding agency in lieu of insurance.

Original documentation is required at time of application for City license registration.

The following items must be submitted:

- TCEQ Irrigator License Card/Certificate – LI license only
- Government Issued Photo ID
- Insurance or bond (City of San Antonio must be listed as Certificate Holder on insurance)
- Authorization Letter (if applicable)
- Escrow Application (if applicable)

Subject: Master Letter of Compliance for Irrigation Installations

The installation of underground irrigation systems in the City of San Antonio (COSA) as well as the Extra Territorial Jurisdiction (ETJ) and the inspections of the same requires all irrigation contractors to complete and submit a notarized Master Letter of Compliance for all irrigation installations on an annual basis when registering or re-registering with the City of San Antonio Development Services Department (DSD).

The following criteria will be used:

- Master Letter of Compliance is to be on DSD letterhead in the format and wording provided by DSD.
- Must have name of license holder, Texas Commission of Environmental Quality (TCEQ) license number, current address, phone number listed. http://www2.tceq.texas.gov/lic_dpa/index.cfm
- P.O. Box is not acceptable.
- The City of San Antonio Plumbing Inspections reserves the right to refuse acceptance of a Master Letter of Compliance from any company.

All irrigation contractors, installers, and interested parties should make themselves familiar with COSA Ordinances 2015-06-18-0563, Chapter 35 City Code of San Antonio, sections 35-510 (j), 35-511 (c)(6), as well as the requirements of Texas Administrative Code Chapter 344 regarding irrigation systems.
